

Summer 2006 Duke Law School Public Interest Fellowship Recipients \$144,559 Awarded

Thirty-eight Duke Law students received summer 2006 public interest employment fellowships totaling \$144,559. (Equal Justice Works provided an additional \$6,000 in supplemental fellowships through its Summer Corps.)

The sources of these fellowships, which are available only to Duke Law students, are: an endowment from former Associate Dean Linda Steckley and her husband Pete Weitzel; an endowment from alumni Richard Burdman '56; an endowment from alumni couple Len Simon '73, and Candace Carroll '74; a grant from the NC State Bar's Interest on Lawyers Trust Account Program (IOLTA); Stanback Fellowships, provided through the Nicholas School for the Environment by donor Fred Stanback; the Howrey Helps Fellowship provided exclusively to a first-year Duke Law student by the Houston law firm of Howrey Simon Arnold & White; a pledge from two members of the Class of 2004 Sarah Dadush and Sohini Chatterjee; a contribution from alumni couple Tom and Caitlin Fulghum '98; and funds raised by Duke Law student members of the Public Interest Law Foundation (PILF), supplemented by a \$10,000 contribution from Duke Law School.

Burdman/Steckley-Weitzel/Carroll-Simon Fellowships - \$19,000

These fellowships provided \$3,800 each for five recipients in 2006, and are funded through three Duke Law School endowments. IOLTA Fellowships - \$12,000

IOLTA fellowships are funded by the NC State Bar's Interest on Lawyers Trust Account program. In 2006, IOLTA gave Duke Law \$12,000 to provide four fellowships of \$3,000 each for Duke Law students. International Development Fellowship - \$6,000

The International Development Fellowship, begun in 2006, is funded primarily by two alumna in the Class of 2004 – Sarah Dadush and Sohini Chatterjee. It is for students to spend all or a part of the summer interning at a non-governmental organization or pursuing an independent research project in a developing country, working on issues such as women's rights, foreign direct investment, land and water rights, or international trade. The amount is not pre-set and applicants present a budget of their needs. The 2006 recipients are:

The Public Interest Law Foundation (PILF) is a Duke Law School student organization dedicated to raising funds for summer public interest fellowships. It raised enough funds in 2005-06, including a \$10,000 contribution from Duke Law School, to award \$67,559 in summer fellowships. These include 13 "full" fellowships of \$3,500 each for a total of \$45,500, 4 fellowships for those working part of the summer for a total of \$9,450 and 12 "thank you grants" to participants who won other fellowships for a total of \$12,609.
