



Reuben Everett Cyber Fellow

Duke University School of Law is accepting applications for an inaugural Ruben Everett Cyber Fellow.

The fellow will hold a joint appointment in both the Duke Center on Law & Tech and the Center on Law, Ethics and National Security. By working closely with faculty members in these and related centers, the fellow will help advance the Law School's role as a leader in fields at the intersection of law and technology, privacy, and cybersecurity.

Duke Center on Law and Tech

The Duke Center on Law and Tech ("DCLT") orchestrates many of Duke's leadership activities in legal technology and specifically aims:

- to bolster the depth and interconnectedness of Duke's offerings at the intersection of law and technology;
- to understand, re-imagine, shape, and lead the next generation of tech-enabled legal practice; and
- to employ the tools of the law to ensure that rapidly emerging technologies empower and ennoble people.

Center on Law, Ethics and National Security

The Center on Law, Ethics and National Security ("LENS") promotes education and discussion of the complex issues involved in national security, such as the legal and policy implications of counterterrorism operations at home and abroad, the role of the respective branches of government in security matters, the international law of armed conflict, the impact of security issues on international business endeavors, and the ethical issues of the practice of national security law.

Because national security issues are increasingly intertwined with advances in technology, LENS is committed to promoting scholarship and education in such areas as cybersecurity, cyberespionage, cyber warfare, and the role of artificial intelligence in U.S. security.

The DCLT and LENS work collaboratively with several other centers at Duke.

Cyber Fellowship

Although the precise contours of the position will be tailored to the strengths and interests of the successful applicant and formalized with his or her input, the fellow's duties are expected to include:

- Assisting in designing and implementing seminars, one-day events, and/or conferences at Duke and elsewhere aimed at tackling current issues in privacy, cybersecurity, law and technology, and related areas.
- Contributing to the organization and implementation of existing DCLT and LENS events and projects, such as the annual LENS Conference and supervising DCLT Fellows from various disciplines.
- Assisting in the design and implementation of cyber-related courses, workshops, and other student offerings.
- Inviting speakers to Duke Law to discuss legal and policy issues relating to cyber and emerging technologies.
- Working with faculty members from the Law School (including those affiliated with other centers, such as the Center on Innovation Policy at Duke Law), as well as other schools and departments within the University, to advance Duke's position as a hub for thought leadership in cyber-related fields.

The ideal candidate will have a demonstrated interest and/or expertise in one or more legal or policy areas at the intersection of law and technology. Candidates should have a JD. Strong academic credentials, superior writing and verbal communication skills, and sound judgment are required. The ideal candidate will also exhibit:

- An ability to think creatively about how to maximize the impacts of scholarly work and programmatic efforts.
- A capacity to supervise and collaborate with others, including fellows from other disciplines (*e.g.* computer science, engineering, neurosciences, public policy) who are working on projects at the intersection of law & technology.
- Strong organizational and interpersonal skills, including the ability to organize and plan events without the need for daily supervision.
- A clear and articulated vision for how this Reuben Everett Cyber Fellowship will advance his or her future professional goals.

The start date is the summer or fall of 2018 (with flexibility as to precise date). The salary for the position will be commensurate with fellowships of this type and include Duke University benefits. Initial appointment is for one year, renewable upon mutual agreement of the fellow and the directors of DCLT and LENS for up to one additional year.
