*Senior Lecturing Fellow, July 2020-June 2022*

Co-teach the Immigrant Rights and Advanced Immigrant Rights Clinics. Supervise students in their representation of immigrant clients before U.S. Citizenship and Immigration Services (USCIS), Immigration and Customs Enforcement (ICE), Executive Office for Immigration Review (EOIR), and U.S. Courts of Appeals. Assist with leading community outreach and education, developing *pro bono* student opportunities, and advancing both local and national advocacy strategies.

Teach Race and Immigration, a course which examines the role race has played since the birth of the United States in driving immigration policy both in terms of who is permitted to enter the United States and who is targeted for detention and removal. Topics include the Chinese Exclusion Act, national origin quota system, Japanese internment, Bracero program, post-9/11 registration, expansion of immigration enforcement through the criminal justice system, DACA rescission, the travel bans, and border policy.

## SELECT ADVOCACY EXPERIENCE

Authored comment on a 2023 proposed regulation, USCIS-2022-0016, which unlawfully reduces access to asylum along the southern border of the U.S. The regulation is presently being challenged in court.

Authored a 2021 letter to DHS and DOJ urging the agency to promulgate a regulation clarifying that the state protection element of the refugee definition is satisfied where there is past persecution or a well-founded fear of future persecution, signed by 100 legal scholars across the U.S.

Authored comment on a 2020 proposed regulation, RIN 1125-AA94, which would have radically and unlawfully reduced access to asylum in the U.S. The regulation was enjoined before becoming effective.

Coauthored LB 826, a 2018 bill to protect SIJ eligible youth in Nebraska. LB 826 became an amendment to LB 670, which was signed into law on April 23, 2018.

Testified against LB 505, a 2017 anti-refugee bill aimed at creating onerous and legally dubious reporting requirements for refugee resettlement agencies in Nebraska. The bill died in committee.

Coauthored LB 947, a 2016 bill to provide professional and commercial licenses to work-authorized immigrants. Drafted technical amendments and talking points in support. It became law over Governor's veto.

Testified in favor of and provided technical support for LB 623, a 2015 bill to provide driver's licenses to recipients of DACA. LB 623 also became law over the Governor's veto.

Testified in August 2015 before the Nebraska Committee to the U.S. Commission on Civil Rights against LB 403, a 2009 bill improperly restricting state services for certain immigrants.

Co-lead successful 2014 campaign to end practice of honoring ICE detainer requests in targeted Nebraska jurisdictions, resulting in policy changes in Douglas and Lancaster counties.
