	<p>Pursuant to the verdict the Court enters a judgment for the Plaintiff and against the Defendants, Bayerische Motoren Werke A G, BMW of North America, Inc. and German Auto, Inc., for Four Thousand Dollars (\$4,000.00) compensatory damages and further enters a judgment for the Plaintiff and against the Defendants, Bayerische Motoren Werke A G and BMW of North America, Inc., for Four Million Dollars (\$4,000,000.00) punitive damages. Costs of court are taxed to the Defendants.</p>
